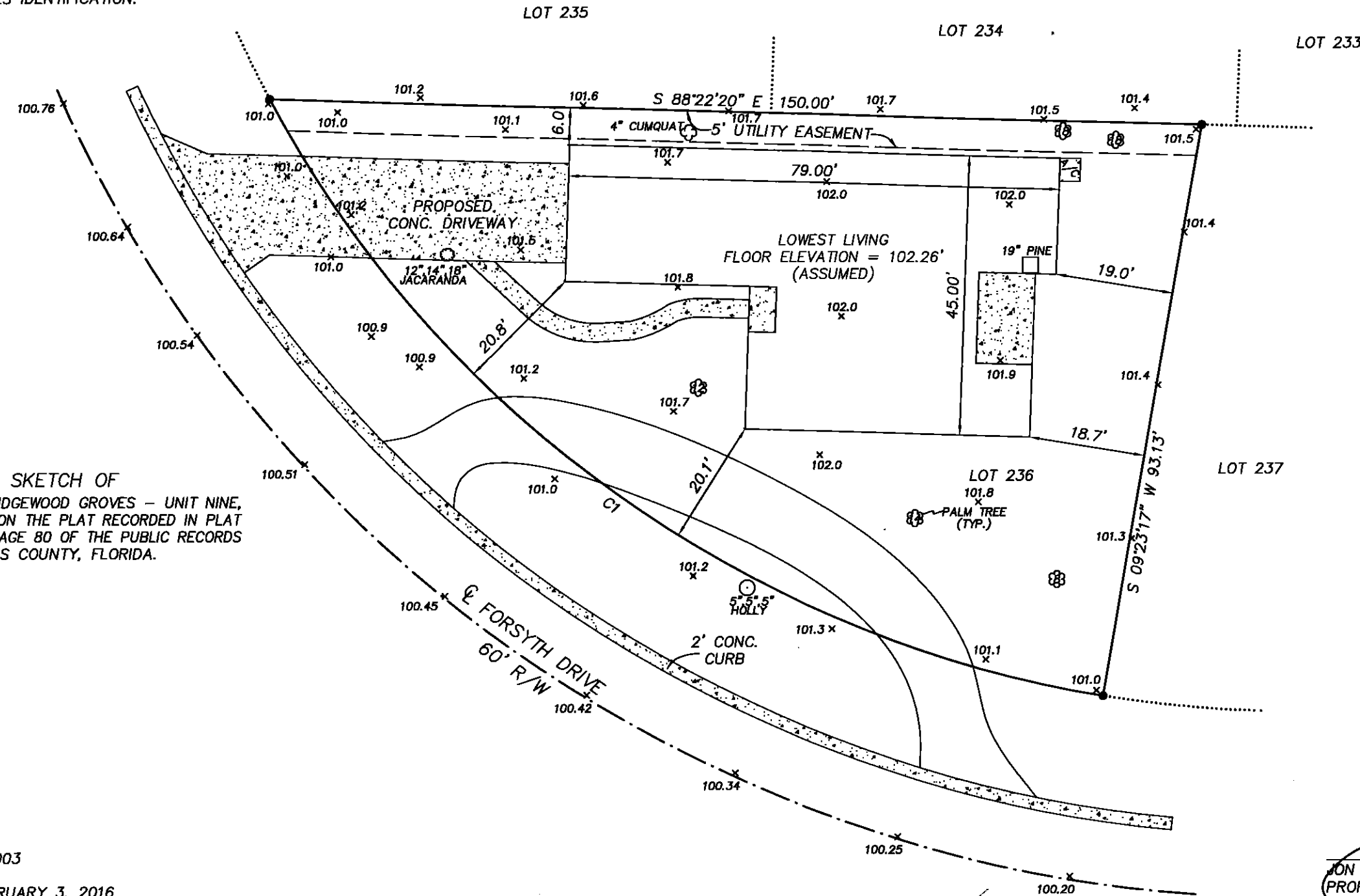
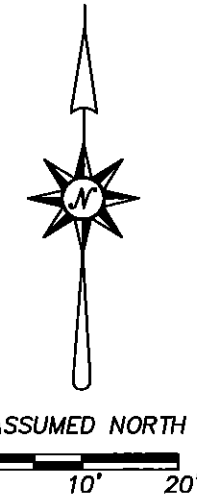


GENERAL NOTES
